



The Committee to Elect Lynda B. Love paid the Gallatin News Examiner to run campaign ads in their newspaper on Friday, November 4, 2016 prior to Election Day on November 8, 2016. The ads failed to appear in the newspaper on that day, and the Gallatin News Examiner has said that it will reimburse the Committee in the amount of approximately \$191.00. It has been over two months now, and reimbursement has yet to be received despite the repeated communications with the Gallatin News Examiner requesting repayment. As soon as repayment is received, the Committee will be able to properly disburse the remaining funds and close this campaign account.
