WHEREAS, the City Council for the City of Gallatin approved Ordinance No. O1709-71 requesting that the Tennessee General Assembly allow amendment of the City of Gallatin's Charter to provide for term limits for the offices of Mayor, District Alderman and Alderman-at-Large and requested that such measure be placed on the November 6, 2018 municipal election ballot for approval or non-approval by the qualified voters of the City of Gallatin;

WHEREAS, the 110th General Assembly of Tennessee approved Private Chapter No. 51 on April 24, 2018 allowing the City of Gallatin's Charter to be amended by deleting from the first paragraph of Article III, Section 1, the following language:

; and when two or more persons shall have an equal number of votes for any elective office, the election shall be determined by a majority of the votes of the Council-elect:

and by substituting instead the following:

When two (2) or more persons shall have an equal number of votes for any elective office, the election shall be determined by a majority of the votes of the Council-elect. No person elected and qualified to the office of Mayor, District Alderman, or Alderman-at-Large shall be eligible for the succeeding term in the same office if such person has served more than one-half (1/2) of a four-year term and a consecutive completion of three (3) four-year terms in that particular office. For purposes of this section, the office of District Alderman and Alderman-at-Large shall be considered separate elected offices.

WHEREAS, the Tennessee General Assembly determined that Private Chapter No. 51 shall have no effect unless it is approved by a majority of the number of qualified voters of the City of Gallatin and that the local legislative body shall determine whether such referendum shall be part of the next regularly scheduled election or if a special election shall be called.

NOW THEREFORE BE IT RESOLVED BY THE CITY OF GALLATIN, TENNESSEE, that an election shall be called for the qualified voters of Gallatin to determine whether the City of Gallatin's Charter shall be amended to provide for term limits for the offices of Mayor, District Alderman, and Alderman-at-Large as set forth by Act of the 110th Tennessee General Assembly, Private Chapter No. 51. The question to be on the ballot shall be as follows:

ORDINANCE AMENDING ARTICLE III, SECTION 1 OF THE CITY OF GALLATIN, TENNESSEE CHARTER AS ESTABLISHED IN CHAPTER 67 OF THE PRIVATE ACTS OF 1953 AND AS AMENDED THEREAFTER TO ESTABLISH TERM LIMITS FOR THE OFFICES OF MAYOR, DISTRICT ALDERMAN, AND ALDERMAN-AT-LARGE

WHEREAS, the City Council for the City of Gallatin, Tennessee passed Ordinance No. O17Ø1-4 on two readings dated January 17, 2017 and February 7, 2017 requesting an amendment to the Charter to provide term limits of no more than three consecutive terms for the Mayor, District Alderman and Alderman-at-Large, if the Ordinance was approved by referendum vote of the citizens; and

WHEREAS, the City of Gallatin forwarded Ordinance No. O17Ø1-4 to the Tennessee legislature for consideration of the Charter amendment as required by law; and

WHEREAS, the 110th General Assembly of the State of Tennessee passed Private Chapter No. 29 on May 8, 2017, allowing amendment of the City of Gallatin's Charter to include term limits, upon approval of a majority of the number of qualified voters of the City of Gallatin voting in an election on the question of whether or not the amendment should be approved; and

WHEREAS, the 110th General Assembly declared that the local legislative body must determine whether such referendum shall be part of the next regularly scheduled election or if a special election shall be called; and

WHEREAS, the City Council for the City of Gallatin has determined no special election shall be called but instead has determined that the referendum should be placed on the November 6, 2018 federal and state general and municipal election ballot rather than the next regularly scheduled election set for May 1, 2018, the Sumner County Primary, as required by Private Chapter No. 29; and

WHEREAS, to clarify the timing of the referendum for approval or non-approval of the voters of the City of Gallatin and to ensure full compliance with Tennessee Code Annotated Section 8-3-202, the City Council for the City of Gallatin hereby requests that the General Assembly for the State of Tennessee approve amendment of its Charter as set forth herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GALLATIN, TENNESSEE, as follows:

Chapter 67 of the Private Acts of 1953, as subsequently amended, Article III, Section 1 is amended by adding the following language immediately after the sentence "When two
 or more persons shall have an equal number of votes for any elective office, the election shall be determined by a majority of the votes of the Council-elect:"

For purposes of this section, the office of District Alderman and Alderman-at-Large shall be considered separate elected offices."
- 2. After passage of this Ordinance by the Tennessee General Assembly, this Ordinance shall have no effect unless it shall receive final approval by a majority of the number of voters of the City of Gallatin in a referendum held for the purpose of approval or non-approval of this Charter amendment in the November 6, 2018 municipal election. Following certification of the results of the referendum by the Sumner County Election Commission, the approval or non-approval of this Ordinance and Charter amendment by referendum shall be certified by the Mayor of the City of Gallatin to the Tennessee Secretary of State.

Susan:

I hope you are doing well! I received the attached signed bill from the Legislature. I spoke with Leah Dennen and Anthony Holt. As we discussed in July of last year, the language of the bill should read "..be scheduled with the next Gallatin municipal election..." the way it is written, it states in Section 3 "The local legislative body shall determine whether such referendum shall be part of the next regularly scheduled election or if a special election shall be called." The City of Gallatin is the local legislative body. The next election is August 2, 108. As I understand from previous discussions, the City of Gallatin does NOT want to call and pay for a special election, and the City of Gallatin DOES want the election held with the regular Gallatin municipal election, which will be November 6, 2018. My suggestion would be for the City of Gallatin to defer action on the matter until after the August 2 election, and then have the council take action which would result in the referendum being placed on the ballot for the November 6, 2018 election. The other option is to take NO action — which means the private act would expire, as it did before, and it could be taken up next legislative session. However, if the language is not changed and it remains "As Is", that would place the matter on the ballot on the March, 2020 Presidential Preference Primary.

Please let me know how you would like to proceed.

CITY OF PORTLAND, TENNESSEE

No. 18 - 21

SECOND READING

AN ORDINANCE CALLING FOR A REFERENDUM ON THE PROPOSITION TO INCREASE THE LOCAL OPTION SALES TAX RATE

WHEREAS, the City of Portland recognizes that pursuant to the authorization in T.C. A. § 67-6-701, et seq., the Local Option Revenue Act, municipalities may, upon approval of a majority of its citizens voting on the issue, levy a local option sales tax rate up to 2.75%; and

WHEREAS, the present local option sales tax rate in the City of Portland is 2.25%; and

WHEREAS, it is deemed to be in the best interests of the City for the local option sales tax rate to be increased by .50 % to 2.75%; and

Now Therefore BE IT Ordained, by the Mayor and City Council of the City of Portland, Tennessee:

<u>Section 1</u>. Subject to the referendum required by the Local Option Revenue Act, the local sales and use tax is hereby increased from 2.25% to 2.75%.

Section 2. The Sumner County and Robertson County Election Commissions are hereby requested to hold a referendum on whether to increase the local option sales tax as described in Section 1 above, as required by law.

Section 3. If a majority of those voting in said referendum vote for the tax rate imposed by this ordinance, collection of the increased tax levied by this ordinance shall begin on the first day of the month occurring thirty (30) days after the Election Commission makes its official canvass of the election returns.

Section 4. The Tennessee Department of Revenue shall collect the additional tax imposed by this ordinance, concurrent with the collection of the state and local tax now being collected for the City of Portland, in accordance with the rules and regulations which may be amended, added, or rescinded by the department.

Section 5. The City Recorder of the City of Portland is designated to receive any notice of a payment made under protest, and shall be the official against whom suit, if any, may be brought for recovery of any tax, penalty, and interest which the Tennessee Department of Revenue has collected and which is alleged by the taxpayer to be illegal or improper.

<u>Section 6.</u> A certified copy of this ordinance shall be transmitted to the Tennessee Department of Revenue and the Robertson County and Sumner County Election Commissions. The Voter Registrars of the respective counties are requested that the following question be placed on the November 2018 general election:

Shall Ordinance No. 18-21 (passed on April 2, 2018 and April 16, 2018) which increases the city's sales tax from 2.25% to 2.75%, except where the sales tax rate is limited or modified by statute, BE APPROVED, with the additional proceeds from the increase in the sales tax to be used for Public Safety.

CITY OF PORTLAND, TENNESSEE

No. 18 - 21

FIRST READING

AN ORDINANCE CALLING FOR A REFERENDUM ON THE PROPOSITION TO INCREASE THE LOCAL OPTION SALES TAX RATE

WHEREAS, the City of Portland recognizes that pursuant to the authorization in T.C. A. § 67-6-701, et seq., the Local Option Revenue Act, municipalities may, upon approval of a majority of its citizens voting on the issue, levy a local option sales tax rate up to 2.75%; and

WHEREAS, the present local option sales tax rate in the City of Portland is 2.25%; and

WHEREAS, it is deemed to be in the best interests of the City for the local option sales tax rate to be increased by .50 % to 2.75%; and

Now Therefore BE IT Ordained, by the Mayor and City Council of the City of Portland, Tennessee:

<u>Section 1</u>. Subject to the referendum required by the Local Option Revenue Act, the local sales and use tax is hereby increased from 2.25% to 2.75%.

<u>Section 2.</u> The Sumner County and Robertson County Election Commissions are hereby requested to hold a referendum on whether to increase the local option sales tax as described in Section 1 above, as required by law.

Section 3. If a majority of those voting in said referendum vote for the tax rate imposed by this ordinance, collection of the increased tax levied by this ordinance shall begin on the first day of the month occurring thirty (30) days after the Election Commission makes its official canvass of the election returns.

Section 4. The Tennessee Department of Revenue shall collect the additional tax imposed by this ordinance, concurrent with the collection of the state and local tax now being collected for the City of Portland, in accordance with the rules and regulations which may be amended, added, or rescinded by the department.

Section 5. The Finance Director of the City of Portland is designated to receive any notice of a payment made under protest, and shall be the official against whom suit, if any, may be brought for recovery of any tax, penalty, and interest which the Tennessee Department of Revenue has collected and which is alleged by the taxpayer to be illegal or improper.

Section 6. A certified copy of this ordinance shall be transmitted to the Tennessee Department of Revenue and the Robertson County and Sumner County Election Commissions. The Voter Registrars of the respective counties are requested that the following question be placed on the November 2018 general election:

Shall Ordinance No. 18-21 (passed on April 2, 2018 and April ____, 2018) which increases the city's sales tax from 2.25% to 2.75%, except where the sales tax rate is limited or modified by statute, BE APPROVED, with the additional proceeds from the increase in the sales tax to be used for Police and Fire Departments.
