

**Sumner County Election Commission
Regular Monthly Meeting Minutes
Tuesday, May 08, 2018**

Members present: Chairman M. Allen Ehmling, Secretary Patricia D. Collins and Member John W. Smith. Also present: Lori D. Atchley, Administrator of Elections and Annette Haw, Assistant Administrator of Elections. The meeting convened at 4:00 p.m. in Room 106 in the County Administration Building, Gallatin TN and a quorum was present.

I. Call meeting to Order

The meeting was called to order, motion by Commissioner Smith, seconded by Commissioner Collins and the motion passed 3-0.

II. Approve Agenda

The Agenda was approved with a motion by Commissioner Smith, seconded by Commissioner Collins and the motion passed 3-0.

III. Old Business

A. Approve minutes of April 10, 2018 with a motion by Commissioner Collins, seconded by Commissioner Smith, and the motion passed 3-0.

Commissioner J. Michael Fussell arrived and joined the meeting at 4:02 p.m.

IV. New Business

A. Commissioners present inspected 72 newly processed voter registration applications out of the total registrations of 717 processed as required by statute with no discretions noted. All Commissioners present signed the report.

B. No appeals.

C. Report from Administrator

AOE read the results from the May 1, 2018 election for Certification (attached). Motion to certify the election by Commissioner Fussell, seconded by Commissioner Smith and the motion passed 4- 0.

AOE presented the August 2, 2018 candidate list that was approved with a motion by Commissioner Smith and seconded by Commissioner Fussell and passed 4-0.

AOE and AAOE presented the August 2, 2018 poll worker list, motion by Commissioner Collins and seconded by Commissioner Fussell to approve the poll worker list, with the caveat that the AOE and the AAOE could fill vacant positions due to death, illness, other vacancies etc.

AOE advised that St. Timothy's Lutheran Church in Hendersonville was not a good location due to high traffic on Gallatin Road. Traffic Officers stated that they were almost hit by vehicles several times throughout the day. AOE advised multiple other locations had been contacted without success. AOE recommended returning to City Hall, although not ideal due to lack of parking; however, did advise that we could check with Mayor about blocking last row of parking for "Voter Only" parking. Motion by Commissioner Fussell and seconded by Commissioner Collins to move Hendersonville Early Voting to Hendersonville City Hall and the motion passed 4-0. AOE stated that a more suitable location would continue to be researched.

AOE recommended that the June 12, 2018 meeting time be moved to 2:00 p.m. due to 1) certifying the Early Voting and Nursing Home Machines, and possibly the Election Day Machines if programmed and 2) locking the Absentee and Provisional Ballot Bags. All Commissioners agreed and noted to properly notice the meeting.

AOE concluded the Administrator report.

V. **Report From Election Commissioners**


Chairman Ehmling had no report.


Commissioners had general discussion about Election Day precinct visits.





