### Pre-General

This report is only required for candidates participating in the August 2 General Election and November 6 General Election  
Local PACS are also required to file.

### Second Quarter Report

If you were a candidate in the May 1 primary election, the report will cover the period April 22, 2018 through June 30, 2018

If you were not a candidate in the May 1, 2018 primary election, but have an open campaign account, the report will cover the period April 1, 2018 through June 30, 2018.

### Third Quarter Report

If you were a candidate in the August 2, 2018 general election, the report will cover the period July 24, 2018 through September 30, 2018.

If you were not a candidate in the August 2, 2018 general election, but have an open campaign account, the report will cover the period July 1, 2018 through September 30, 2018.

### Fourth Quarter Report

If you were a candidate in the November 6, 2018 general election, the report will cover the period October 30, 2018 through January 15, 2019.

If you were not a candidate in the November 6, 2018 general election the report will cover the period October 1, 2018 through January 15, 2019.
