Pre-Primary

This report is only required for candidates participating in the March 3 Sumner County Primary Election

Pre-General

This report is only required for candidates participating in the Aug. 6 General Election and Nov. 3 General Election

First Quarter Report

If you were a candidate in the March 3, 2020 primary the report will cover the period February 23, 2020 through March 31, 2020.

If you were not a candidate in the March 3, 2020 primary election, but have an open campaign account, the report will cover the period January 16, 2020 through March 31, 2020.

Second Quarter

All reporting periods are the same.

Third Quarter Report

If you were a candidate in the August 6, 2020 general election, the report will cover the period July 28, 2020 through September 30, 2020.

If you were not a candidate in the August 6, 2020 general election, but have an open campaign account, the report will cover the period July 1, 2020 through September 30, 2020.

Fourth Quarter Report

If you were a candidate in the November 3, 2020 general election, the report will cover the period October 25, 2020 through January 15, 2021.

If you were not a candidate in the November 3, 2020 general election the report will cover the period October 1, 2020 through January 15, 2021.
