## Fourth Quarter Report

If you were a candidate in the November 8, 2022 general election, the report will cover the period October 30, 2022 through January 15, 2023.

If you were not a candidate in the November 3, 2020 general election the report will cover the period October 1, 2022 through Jaunary 15, 2023.
