When two (2) or more persons shall have an equal number of votes for any elective office, the election shall be determined by a majority of the votes of the Council-elect. No person elected and qualified to the office of Mayor, District Alderman, or Alderman At-Large shall be eligible for the succeeding term in the same office if such person has served more than one-half (1/2) of a four (4) year term and a consecutive completion of three (3) four year terms in that particular office. For purposes of this section, the office of District Alderman and Alderman At-Large shall be considered separate elected offices.
