

No funds may be received or expended for a future election until a political treasurer has been appointed. A new form must be filed if the treasurer is changed.

Committees that make contributions only to candidates for state public office must file this form and a \$100 annual fee with the Registry of Election Finance, 404 James Robertson Parkway, Suite 1614, Nashville, TN 37243-1360. Committees that make contributions only to candidates for local public office must file with the local county election commission in the county where the contributions are made. Committees giving to both state and local candidates should file the original with the Registry and a copy with the county election commission in any county the committee is making contributions.
