

**ELECTION NOTICE EARLY/ABSENTEE VOTING
CITY OF MILLERSVILLE SPECIAL ELECTION
CITY COMMISSIONER (UNEXPIRED TERM)
TUESDAY, DECEMBER 19, 2023**

The Sumner County Election Commission will conduct early voting for any eligible voter in Sumner County, TN to cast a ballot by personal appearance on the following dates, times and ONE location. Refer to the Robertson County, TN notice and office for location of voting as this election will be held for both Sumner County and Robertson County for the City of Millersville Special Election at two different locations for both election day and early voting.

NOTICE: LAST DAY TO REGISTER TO VOTE IS November 20, 2023 for
the December 19, 2023 Special Election.

Registered voters who are unable to vote at their polling place on Election Day may vote by one of the following methods.

1. VOTING EARLY BY PERSONAL APPEARANCE

November 29, 2023 through December 14, 2023, a voter desiring to vote by personal appearance shall go to the location above to cast their ballot. The last day to early vote by personal appearance is Thursday, **December 14, 2023**. **State law requires voters to present a Federal or State of Tennessee Photo ID to vote, unless an exception applies.** Voters who do not have proper Photo ID, and an exception does not apply, will be allowed to vote a provisional ballot and will have two (2) business days after Election Day to appear at the Sumner County Election Commission office and present the proper Photo ID and sign an affidavit. **Examples of acceptable Photo ID include:** Tennessee Driver License with Photo, United States Passport, Tennessee Department of Safety Photo ID, United States Military Photo ID, or a State of Tennessee issued Handgun Carry Permit with Photo.

2. VOTING BY MAIL

A voter **must meet certain legal qualifications to vote by mail**. A voter desiring to vote absentee by mail must request an absentee ballot application from the Sumner County Election Commission in person, at office, by telephone, by fax, by email OR by mail. Such a request for an application must be received no later than **December 12, 2023**. The request can serve as an application for ballot if it contains the following: registered voter name, address of residence, social security number, voter's date of birth, election they wish to participate in, address to which the ballot is to be mailed, the reason a voter wishes to vote absentee, and the voter's signature.

The Sumner County Election Commission does not discriminate on the basis of disability. If there are questions about needed accommodations in the voting process call 615-452-1456.
