

**SUMNER COUNTY ELECTION COMMISSION
REGULAR MONTHLY MEETING MINUTES
TUESDAY, JANUARY 9, 2024, 1:00 P.M.**

Members present: Chairman M. Allen Ehmling; Secretary Denise D. Shepherd; Commissioner Patricia D. Collins; Commissioner J. Michael Fussell (arrived at 1:04 p.m.); and Commissioner Jeffery B. Hulsey. Also present: Lori D. Atchley, Administrator of Elections (AOE) and Annette P. Haw, Assistant Administrator of Elections (AAOE).

I. CALL MEETING TO ORDER

The meeting was called to order at 1:00 p.m. by Chairman Ehmling with a motion by Commissioner Hulsey, seconded by Commissioner Collins and the motion passed 4 – 0. (AYE Ehmling, Shepherd, Collins, Hulsey.) A quorum was present.

II. APPROVE AGENDA

A. INSPECTION – APPEAL PROCESSED VOTER REGISTRATION APPLICATIONS

B. INSPECTION – NEWLY PROCESSED VOTER REGISTRATION APPLICATIONS

Commissioners inspected 54 voter registration applications out of 536 new registration applications with no discrepancies noted. Commissioners present signed the report to be submitted to the State Division of Elections.

C. REPORT FROM ADMINISTRATOR

- FACILITY UPDATE

AOE advised the SCEC continues to operate in two separate locations, and that no ruling had yet been made by Judge Louis Oliver in Chancery Court following the November 17, 2023, court date, thus the matter remains unresolved.

- BUDGET UPDATE

The budget committee met on January 8, 2024, and passed a motion to submit the request to the full county commission to approve the \$34,275.74 appropriation request by the SCEC for services for the Auxiliary Building at 1019 Union School Road required for the SCEC to operate the March 5, 2024, PPP.

- CERTIFY DECEMBER 19, 2023, MILLERSVILLE SPECIAL ELECTION

All Election Commissioners reviewed the Sumner and Roberston County election results and signed the certification documents. Chairman Ehmling and AOE Atchley signed the absentee certification document.

- LOCK AND SEAL MARCH 5, 2024 BALLOT BAGS

AOE called the lock and seal numbers for the provisional, absentee and other required ballot bags. Commissioners verified the lock and seal numbers, attached said locks and seals to the respective ballot bags and signed the certification report.






