The Appointment of Political Treasurer statement must be used to appoint a political treasurer as required by the Campaign Financial Disclosure Act (T.C.A. § 2-10-105) for state and local candidates and single-candidate political campaign committees. A state candidate may not receive or expend funds for an election until a political treasurer has been appointed for that election. A candidate may appoint ~~themselves~~ ^{themselves or their} as political treasurer. A new form must be filed if the treasurer is changed. Some local candidates may be exempt from completing this form. Candidates should check with the county election commission for more information.

Candidates for state public office must file their original Appointment of Political Treasurer statement ONLY with the Registry of Election Finance at the address above.

Candidates for local public office must file their original Appointment of Political Treasurer statement ONLY with their county election commission.
