Machine:
Place an "X" by pushing the gray button next to the Candidate's name for whom you wish to vote. Place an "X" next to Retain or Replace for the Retention Questions for Judges. When finished, press the red "CONFIRM" vote button, and then press the "CAST VOTE" button.

NOTE: Once the "CAST VOTE" button is pushed, there is NOTHING that can be done to make changes to your vote.

Paper Ballot:
(For Absentee or Provisional Voting Only)
Fill in the circle next to the Candidate's name for whom you wish to vote. Fill in the circle next to Retain or Replace for the Retention questions for Judges. Complete the ballot flap and sign. Place the ballot in the envelope provided, seal and mail if an Absentee Ballot, OR place in the Locked Provisional Ballot Bag provided by the Election Official on site if during Early Voting or on Election Day.
