A state candidate may not receive or expend funds for an election until a political treasurer has been appointed for that election. A candidate may appoint himself or herself as political treasurer. A new form must be filed if the treasurer is changed. Some local candidates may be exempt from completing this form. All candidates should check with the county election commission for more information.

Candidates for state public office must file their original Appointment of Political Treasurer statement ONLY with the Tennessee Bureau of Ethics and Campaign Finance, 404 James Robertson Parkway, Suite 104, Nashville, TN 37243-1360.

Candidates for local public office must file their original Appointment of Political Treasurer statement ONLY with their county election commission.
